

Community Child Care Center



Head Start is a federally funded preschool program for low income children (ages 3 – 5) and their families living in Pullman. Head Start is designed to provide early learning and comprehensive services that support the development of the whole child and support family wellness.

Early Head Start delivers home-based services to low-income pregnant women and children birth to three in Whitman County. Family Consultants support healthy child development and provide family support services within the home environment.

ECEAP (Early Childhood Educational Assistance Program) early learning programs are located in Pullman, Colfax, Endicott, Rosalia, Tekoa, Palouse and Garfield. We partner with local school districts and WSU to provide ECEAP services to qualifying children and their families who live in their communities.

Child Care programs are located in Pullman and Colfax, and provide extended care and high-quality early childhood education services to children ranging from 1 – 12 years of age in tuition-based programs.

Philosophy and Services

It is the philosophy of Community Child Care Center (CCCC) to view all children as individuals, each unique in their personal development, who enter into our program with many types of experiences and environmental factors. We acknowledge and value the differences and diversity in our children and our families. We meet the child where they are and promote their development by providing high quality early childhood education and care. We create healthy, nutritious environments for children, while providing comprehensive services that reinforce and maintain healthy physical growth and development. The formation of family partnerships is critical as we understand each families unique circumstances, coupled with their child's development, and help move them forward. We design high quality environments for children, parents, and staff that build a sense of community which is safe, diverse, and accepts individuality.

CCCC has provided high quality early childhood education services on the Palouse since 1970.

Today we provide services to approximately 275 children in seven communities through-out Whitman County. We hold sub-contracting agreements/contracts with 5 local school districts located in Endicott, Rosalia, Tekoa, Palouse, and Garfield as well as Washington State University Children's Center.

We operate three centers in Pullman and Colfax; the St James, Greyhound Way,

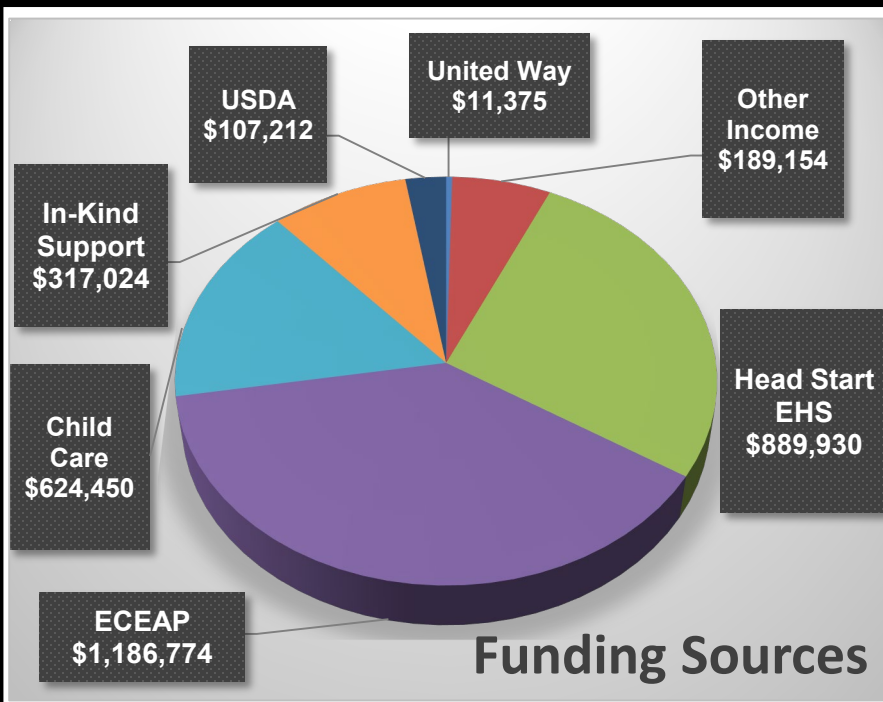
and Colfax centers. Preschool services are provided

through full-day, school-day, and part-day center-based programs, while our Early Head Start program provides home-based services to children birth – three years. We also provide after school programming at our St James and Colfax centers, and a toddler classroom at St James.



Fiscal and Audit Information

Community Child Care Center is funded through a combination of Federal and State grants, and public and private funding. Our funding sources include Head Start / Early Head Start, ECEAP, parent paid tuition, DCYF child care subsidies, USDA food reimbursements, United Way, and a small number of other grants and contracts.

Auditing and Monitoring Events

CliftonLarsonAlan completed our 2021 Independent outside audit with no findings, this clean audit placed us in a low-risk auditee category. The most recent review of Head Start occurred in 2019, with no findings issued. ECEAP's last fiscal review occurred in November, 2021 and sited a minor correction on the calculation of mileage reimbursement.



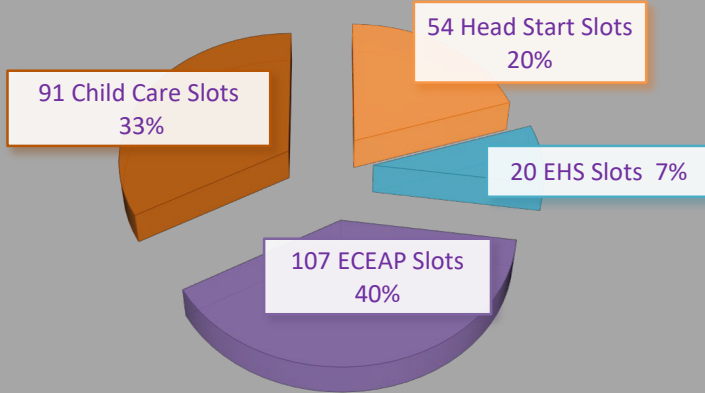
BUDGET EXPLANATION*

Revenue	\$3,325,920	During FY22, we continued to receive a variety of COVID relief funds. We received revenues from the PPP Loan program (Paycheck Protection Program), ARP (American Rescue Plan), CRRSA (COVID Response and Relief), and the DCYF Child Care Stabilization Grants. This has resulted in a substantial increase to our net income for the year.

➤ Our State and Federally funded slots comprise 67% (181 slots) of our total enrollment, with Child Care slots making up the other 33% (90 slots).

➤ Cumulatively we provided services to 379 children between all programs in the 2021-2022 program year.

➤ Community Assessment data shows we are serving above 100% of eligible HS / ECEAP children in Whitman County. EHS only serves 10% of eligible children.

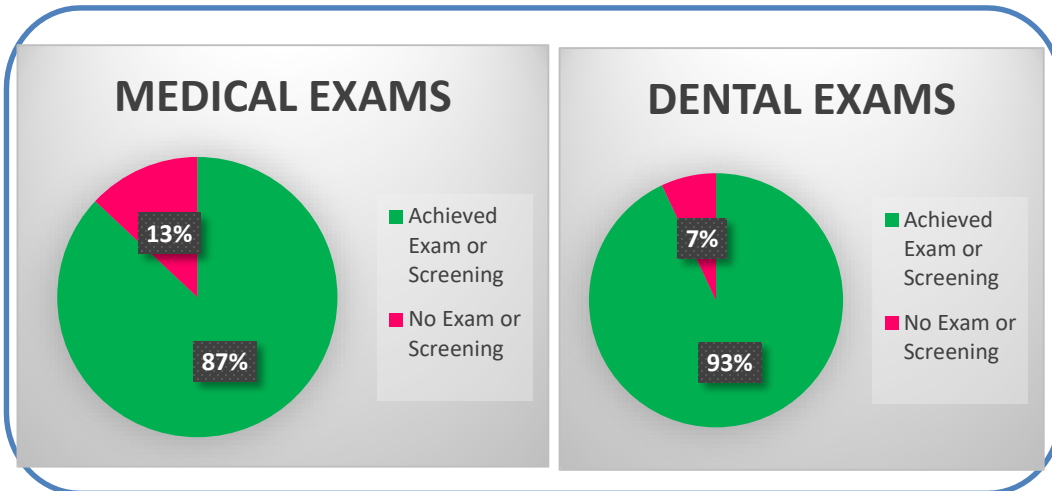

Health and Nutrition Services

When children's physical health needs and nutrition needs are being met, they open themselves up to the world around them and take in everything that their surroundings have to offer. When children are experiencing pain, discomfort, or changes in their vision, hearing, or body functions, they are not always able to communicate to their caregiver or teacher what they are feeling. Instead, children may show changes in attention, behavior, and in their typical disposition. Our Advocates work with families to help coordinate and facilitate children being connected with a primary physician, a dentist, and assist families in navigating the healthcare system in order to meet all their child's health and dental care needs.

Health Services help to identify areas of concern for a child's physical health that may be impacting their ability to learn, grow, and develop. We provide:

- Dental screening clinics, includes fluoride and sealant services
- Hearing and Vision Screenings
- Height and Weight Measurements
- Coordination of referrals to specialists as needed
- Management and tracking of medical and dental exams, immunizations, and other health items with identified follow-up treatment



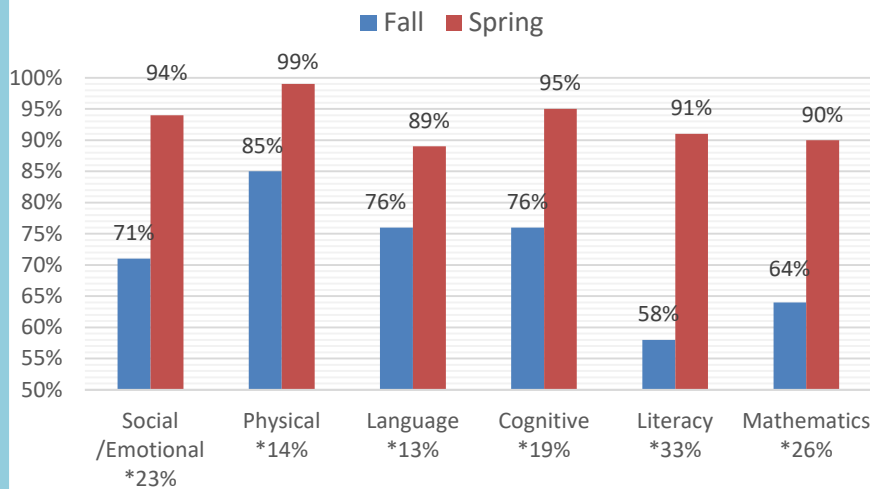
Our Nutrition Program offers children new food experiences and frequent fresh fruits and vegetables. We believe when children fuel their bodies with well-balanced meals, they are ready for the learning environment. Consultation with a Registered Dietician is provided as needed or requested.



Early Childhood Education

Our educational and school readiness approach centers around the development of the whole child. We emphasize the development of social-emotional skills in all children, because we recognize that healthy social and emotional development provides children with the foundation needed for learning and success. Teachers use a developmentally appropriate curriculum, which is individualized through observation and assessment of each child's individual strengths and needs. We work with parents to develop individual goals that are uniquely appropriate to each child. Fun, exciting, and individualized activities are planned throughout learning centers to provide children with many opportunities to acquire and practice their new learning skills, and lead to positive outcomes for all!

% of Children Meeting or Exceeding Expectations



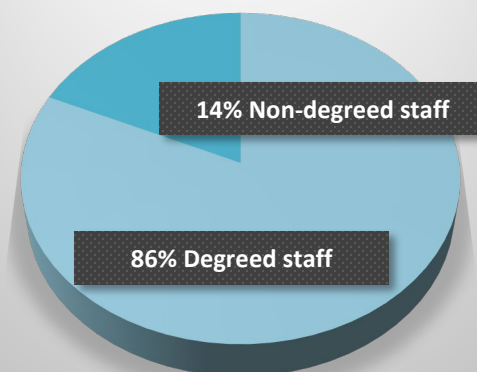

% of Degreed Lead Teachers and Family Advocates



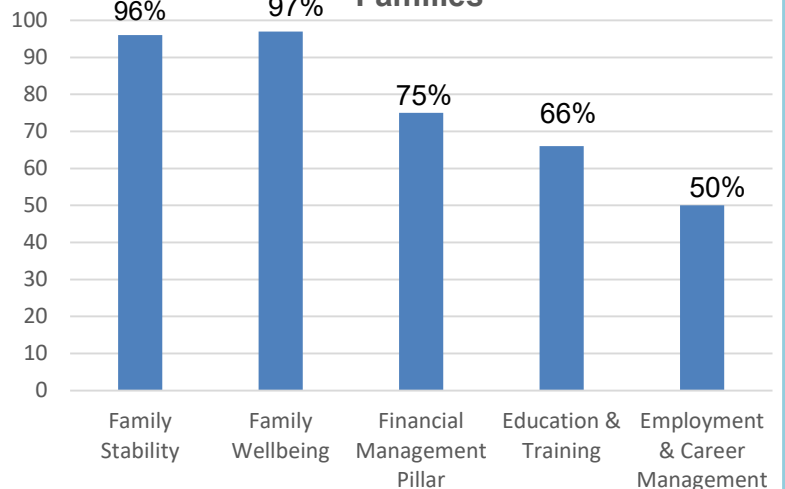
Family Engagement

CCCC provides ongoing education and support to parents to empower them into being an advocate for their child's ongoing development and educational process.
